Mayor Pavletic polled the board for input regarding ordinance:

Alderman Davis stated he has heard no input of objection to ordinance.

Alderman Beard stated none.

Alderwoman Alston stated none.

Alderwoman Treadway stated none.

Alderman Hankins stated everything he has heard has been positive.

Attorney Jackson stated none.

Ms. Buckner stated Mr. Joseph Jones came into office and stated that some Pits are tame and some are violent. His dog stays in the house but happened to get out and was picked up.

Mr. Grantland stated Mr. Jones also spoke with him. He released Mr. Jones' dog and Mr. Jones took him to stay in the county.

Ms. Peggy Haynie ask how one breed could be taken off the list but the other two left on the list?

Alderman Hankins stated it was determined by national numbers. The top three were the same but the Doberman had dropped down. The main issue remains the Pit Bull.

Ms. Haynie asked was it not looked at before the Doberman was added to vicious dog list.

Attorney Jackson stated in the early 1990's there had been some local attacks and deaths in Shelby County right on the heels of a death in Lauderdale County. The statistics at that time did support the ordinance passed at that time as a measure to be proactive in dealing with those breeds. This committee not only looked at the state, national and local statistics for the various breeds already breed specific in the statue but they considered other Tennessee cities which have similar ordinances and the majority do have ordinances that in some way control the ownership of Pit Bulls. People living in the city limits live closer to one another and come into contact with each other and animals more closely and in mass. In many cities there are bans against ownership of Pit Bulls. This is sort of the middle ground in not completely banning ownership but putting restrictions in place that really do regulate and control what happens if you decide to own one. Pit Bulls, by nature, can be aggressive and people tend to abuse that quality. Cities are trying to be proactive in protecting people and other domestic animals against the people who do that.

Alderman Davis stated the German Shepherd was eliminated from the list as well.

Ms. Haynie stated there are other vicious dogs, such as the Chow. Alderman Hankins stated in this ordinance any dog that commits a violent act becomes labeled as a vicious dog.

Attorney Jackson stated there just isn't as wide-spread ownership of the Chow as it is the Pit Bull so they don't tend to be a public issue.

Attorney Jackson emphasized to the board that there is going to have to be a data bank of information maintained by animal control officer. A data bank of dogs that have had previous complaints so that we will know what provisions apply.
