The Board continued its discussion relative to the request of Ripley Power & Light Co. to amend the City Charter to remove its department head from Section 6 of the City Charter and to establish a new provision relative to both the department head and the utility board. Alderman Thompson made a motion to amend the charter to request that the local delegation introduce a private act this year to amend Section 6 of the Ripley City Charter to finally remove this discussion about Power and Light Board of Public Utilities, whereupon Mayor Fitzhugh advised that the agenda item addressed only discussion of the topic, not action on the topic. A discussion of the request ensued. An appearance was made by department head Mike Allmand and utility board chairman Phillip Jackson, insistent that the utility board did not lawfully exist without such an amendment, which was disputed by Mayor Fitzhugh. Mayor Fitzhugh addressed certain recently-discovered actions of the utility board, in light of historical documents from the office of the Comptroller of the Treasury, and the status of the utility's audit. Allmand and Jackson both asserted that the City Attorney had made a confidential complaint to the Comptroller's office. BOMA members discussed the need to hear from the City Attorney relative to the status of communications between the attorney and the utility board attorney, and relative to other questions posed by BOMA members.
